PROFILE

Commercial

Daniel is regularly instructed by corporates, funds, lenders, insurers and private clients across a wide range of commercial matters. His work frequently includes fraud claims, tech and data rights, interim relief, and insurance and shareholder disputes.

Recent cases:

Arbitration

Daniel's arbitration practice covers commercial, shareholder, and sports disputes, as well as enforcement and set-aside challenges. He has experience in jurisdiction, confidentiality, and serious irregularity issues.

Recent cases:

- X v Y – Acted for a consultancy in a deferred success fee dispute following a failed M&A transaction.
- X v Y – Acted for a fuel supplier resisting a set-aside application of an LCIA award for lack of jurisdiction and alleged irregularity.
- X v Y – Represented a tenant in a terminal dilapidations arbitration involving £1.5 million in claims.
- X v Y – Acted for a football agent in a Rule K arbitration concerning unpaid commercial commissions.
- X v Y – Acted for an elite athlete in selection dispute proceedings linked to a commercial sponsorship breach.

Company

Daniel handles complex shareholder and corporate governance disputes, including unfair prejudice petitions, breaches of fiduciary duty, and warranty claims following share sales.

Recent cases:

- Acted for respondents in director disqualification proceedings involving insolvency and competition law breaches.
- Advised directors on regulatory exposure under FSMA in relation to crypto securities.
- Acted for a petitioner in s.994 proceedings involving exclusion from management and quasi-partnership breakdown.

Partnership and LLP

Insolvency & Restructuring

Daniel's insolvency work complements his fraud and company litigation practice, particularly in matters involving antecedent transactions, director liability, and international asset recovery. He has a particular focus on the intersection of insurance and insolvency law, particularly in cases where coverage disputes arise in the context of a company's failure.

Recent cases:

- Acted for the liquidators of a UK fintech company pursuing fraudulent trading claims linked to offshore crypto wallets.
- Advised former directors of a logistics company facing wrongful trading allegations during the COVID-19 period
- Instructed on claims arising from £1.5m intra-group payments before insolvency.
- Advised liquidators in a £5m claim against a European manufacturer over supply chain breaches,
- Advised liquidator on *Third Parties (Rights Against Insurers) Act 2010* issue concerning D&O and professional indemnity coverage during insolvency proceedings, and challenges involving avoidance.
